



# 2023-2024 Student Health Insurance Plan for Washington State University

# Who is eligible to enroll?

Graduate Student Assistants who are enrolled in 10 or more credit hours and who have an Assistantship stipend of at least 50% for an academic semester or more; and full time Research Fellows/Trainees who are paid a stipend of at least \$800 per month who are engaged in research similar to that of a Research Assistant will be automatically enrolled in the Plan by the University. Non appointed Graduate Students in WSU Health Science Colleges, including Medicine, Nursing, Pharmacy and Veterinary Medicine, are eligible to be enrolled in this insurance plan unless covered by other insurance.

Eligible students who do enroll may also insure their Dependents. Eligible Dependents are the student's legal spouse or Domestic Partner and dependent children under 26 years of age. See the Definitions section of the Certificate for the specific requirements needed to meet Domestic Partner eligibility.

The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium.

The eligibility date for Dependents of the Named Insured shall be determined in accordance with the following:

- 1. If a Named Insured has Dependents on the date he or she is eligible for insurance.
- If a Named Insured acquires a Dependent after the Effective Date, such Dependent becomes eligible:
  - a. On the date the Named Insured acquires a legal spouse or a Domestic Partner who meets the specific requirements set forth in the Definitions section of the Certificate.
  - b. On the date the Named Insured acquires a dependent child who is within the limits of a dependent child set forth in the Definitions section of the Certificate.

Dependent eligibility expires concurrently with that of the Named Insured.

Please read the certificate of coverage to determine whether this plan is right before you enroll. The certificate of coverage provides details of the coverage including benefits, exclusions, and reductions or limitations and the terms under which the coverage may be continued in force. This plan is underwritten by UnitedHealthcare Insurance Company and is based on policy number 2023-312-1. The Policy is a Non-Renewable One-Year Term Policy.

# **Exclusions and Limitations**

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

- 1. Addiction, such as:
  - Caffeine addiction.
  - Non-chemical addiction, such as: gambling, sexual, spending, shopping, working and religious.
  - Codependency.
- 2. Learning disabilities.

Benefits will be provided for the treatment of a Mental Disorder as described under Benefits for Mental Disorders or Substance Use Disorders in Section 7: Mandated Benefits.

Benefits will be provided for Neurodevelopmental Therapy as described under Neurodevelopment Therapy in Section 6: Medical Expense Benefits.

- Biofeedback.
- 4. Circumcision.
- 5. Cosmetic procedures intended to alter or reshape normal structures of the body in order to change or improve appearance or alter or reshape normal structures of the body without significantly improving physiological function.
  - Cosmetic procedures to correct an Injury or treat a Sickness for which benefits are otherwise payable under the Policy will be paid the same as any other Sickness or Injury.
  - Cosmetic procedures to treat or correct a congenital anomaly will be paid the same as any other Sickness.
- 6. Custodial Care.
  - Care provided in: rest homes, health resorts, homes for the aged, halfway houses, college infirmaries or places mainly for domiciliary or Custodial Care.
  - Extended care in treatment or substance abuse facilities for domiciliary or Custodial Care.
- 7. Dental treatment,
  - Benefits will be provided for accidental Injury to Sound, Natural Teeth as described under Dental Injury in Section 6: Medical Expense Benefits.
  - Benefits will be provided for additional covered Dental Treatment as described under Dental Treatment in Section 6: Medical Expense Benefits.

Benefits will be provided for Pediatric Dental Services as described in Section 21: Pediatric Dental Services Benefits.

- 8. Elective Surgery or Elective Treatment.
- 9. Flight in any kind of aircraft. Injuries sustained while riding as a passenger on a regularly scheduled flight of a commercial airline will be covered the same as any other Injury.
- 10. Foot care for the following:
  - Supportive devices for the foot.
  - Routine foot care including the care, cutting and removal of corns, calluses and bunions (except capsular or bone surgery).

Benefits will be provided for preventive foot care due to conditions associated with metabolic, neurologic, or peripheral vascular disease as described under Diabetes Services in Section 6: Medical Expense Benefits and as described under Benefits for Diabetes in Section 7: Mandated Benefits.

11. Genetic testing.

Benefits will be provided for Medically Necessary genetic testing and maternity related genetic testing as described under Maternity and Genetic Testing in Section 6: Medical Expense Benefits.

- 12. Health spa or similar facilities. Strengthening programs.
- 13. Hirsutism. Alopecia.
- 14. Hypnosis.

- 15. Immunizations. Preventive medicines or vaccines.
  - Benefits will be provided for immunizations or preventive medicines or vaccines provided under the *United States Preventive Task Force* requirements or the *Health Resources and Services Administration (HRSA)* requirements as described under Preventive Care Services in Section 6: Medical Expense Benefits.
- 16. Injury or Sickness for which benefits are paid or payable under any Workers' Compensation or Occupational Disease Law or Act, or similar legislation.
- 17. Injury sustained while:
  - Participating in any intercollegiate or professional sport, contest or competition.
  - Traveling to or from such sport, contest or competition as a participant.
  - Participating in any practice or conditioning program for such sport, contest or competition.
- 18. Investigational services.
- 19. Lipectomy.
- 20. Participation in a riot or civil disorder. Commission of or attempt to commit a felony.
- 21. Prescription Drugs, services or supplies as follows:
  - Therapeutic devices or appliances, including: support garments and other non-medical substances, regardless of intended use.
    - Benefits will be provided for durable medical equipment as described under Durable Medical Equipment in Section 6: Medical Expense Benefits.
  - Drugs labeled, "Caution limited by federal law to investigational use" or experimental drugs.
  - Products used for cosmetic purposes.
  - Drugs used to treat or cure baldness. Anabolic steroids used for body building.
  - Anorectics drugs used for the purpose of weight control.
  - Fertility agents or sexual enhancement drugs.
  - Growth hormones.
  - Refills in excess of the number specified or dispensed after one (1) year of date of the prescription.
- 22. Reproductive services for the following:
  - Procreative counseling.
  - · Genetic counseling and genetic testing.
    - Benefits will be provided for Medically Necessary genetic testing and maternity related genetic testing as described under Maternity and Genetic Testing in Section 6: Medical Expense Benefits.
  - Cryopreservation of reproductive materials. Storage of reproductive materials.
  - Fertility tests.
  - Infertility treatment (male or female), including any services or supplies rendered for the purpose or with the intent of inducing conception. Benefits will be provided for the diagnosis of the underlying cause of infertility as described under Infertility in Section 6: Medical Expense Benefits.
  - Premarital examinations.
  - Impotence, organic or otherwise.
  - Reversal of sterilization procedures.
- 23. Research or examinations relating to research studies, or any treatment for which the patient or the patient's representative must sign an informed consent document identifying the treatment in which the patient is to participate as a research study or clinical research study.
  - Benefits will be provided for treatment of approved clinical trials as described under Approved Clinical Trials in Section 6: Medical Expense Benefits.
- 24. Routine eye examinations. Eye refractions. Eyeglasses. Contact lenses. Prescriptions or fitting of eyeglasses or contact lenses. Vision correction surgery. Treatment for visual defects and problems.
  - Benefits will be provided for Medically Necessary eye examination services, vision correction surgery, or treatment for visual defects or problems when due to a covered Injury or disease process.
  - Benefits will be provided for Pediatric Vision Care Services as described in Section 22: Pediatric Vision Services
    Benefits.
  - Benefits will be provided for limited vision care supplies listed in the Schedule of Benefits.
- 25. Routine Newborn Infant Care and well-baby nursery and related Physician charge.
  - Benefits will be provided for newborn care provided immediately after birth as described under Routine Newborn Care in Section 6: Medical Expense Benefits.
- 26. Preventive care services which are not specifically provided in the Policy, including:
  - Routine physical examinations and routine testing.
  - Preventive testing or treatment.
  - Screening exams or testing in the absence of Injury or Sickness.
- 27. Services provided normally without charge by the Health Service of the Policyholder. Services covered or provided by the student health fee.
- 28. Skeletal irregularities of one or both jaws, including orthognathia and mandibular retrognathia.
  - Benefits will be provided for orthognathic surgery due to temporomandibular joint disorder, Congenital Conditions, Injury and sleep apnea the same as any other Sickness or Injury.
- 29. Deviated nasal septum, including submucous resection and/or other surgical correction thereof.

- 30. Nasal and sinus surgery not related to the treatment of a covered Injury or treatment of chronic sinusitis.
- 31. Sleep disorders.
  - Benefits will be provided the same as any other Sickness for orthognathic surgery due to sleep apnea.
- 32. Speech therapy.
  - Benefits will be provided for speech therapy to restore or improve lost function due to an Injury or Sickness as described under Physiotherapy in Section 6: Medical Expense Benefits.
  - Benefits will be provided for speech therapy provided in relation neurodevelopmental therapy as described under Neurodevelopmental Therapy in Section 6: Medical Expense Benefits.
  - Benefits will be provided for speech therapy provided in conjunction with Habilitative Services the same as any other Sickness.
- 33. Stand-alone multi-disciplinary smoking cessation programs. These are programs that usually include health care providers specializing in smoking cessation and may include a psychologist, social worker or other licensed or certified professional.
- 34. Surgical breast reduction, breast augmentation, breast implants or breast prosthetic devices, or gynecomastia. This exclusion does not apply to benefits specifically provided in Benefits for Gender Affirming Treatment.

  Benefits will be provided for breast surgery as described under Reconstructive Breast Surgery Following Mastectomy in Section 6: Medical Expense Benefits and as described under Benefits for Reconstructive Breast Surgery in Section 7: Mandated Benefits.
- 35. Treatment in a Government hospital, unless there is a legal obligation for the Insured Person to pay for such treatment.
- 36. War or any act of war, declared or undeclared; or while in the armed forces of any country (a pro-rata premium will be refunded upon request for such period not covered).
- 37. Weight management. Weight reduction. Nutrition programs. Non-surgical treatment for obesity. Surgery for removal of excess skin or fat.
  - Benefits will be provided for surgery related to morbid obesity.
  - Benefits will be provided for obesity services as shown on the A & B list of preventive services as recommended by the *United States Preventive Task Force* as described under Preventive Care Services in Section 6: Medical Expense Benefits.

# **UnitedHealthcare Global: Global Emergency Services**

If you are a student insured with this insurance plan, you and your insured spouse, Domestic Partner and insured minor child(ren) are eligible for UnitedHealthcare Global Emergency Services. The requirements to receive these services are as follows:

Domestic Students, insured spouse, Domestic Partner and insured minor child(ren): you are eligible for UnitedHealthcare Global services when 100 miles or more away from your campus address or 100 miles or more away from your permanent home address or while participating in a Study Abroad program.

The Assistance and Evacuation Benefits and related services are not meant to be used in lieu of or replace local emergency services such as an ambulance requested through emergency 911 telephone assistance. All services must be arranged and provided by UnitedHealthcare Global; any services not arranged by UnitedHealthcare Global will not be considered for payment. HealthiestYou physicians are an independent network of doctors who advise, diagnose, and prescribe at their own discretion. HealthiestYou physicians provide cross coverage and operate subject to state regulations. Physicians in the independent network do not prescribe DEA controlled substances, non-therapeutic drugs and certain other drugs which may be harmful because of their potential for abuse. HealthiestYou does not guarantee that a prescription will be written. Services may vary by state.

# **HealthiestYou: Virtual Counselor Access**

Starting on the effective date of your coverage under the student insurance plan, you have access to mental health providers through a national virtual counseling service.\* Psychiatrists, psychologists and licensed therapists are available to you through a variety of communication methods, including phone and video.

When you sign up, you'll complete a questionnaire, choose your provider and select a date and time for your appointment. Appointments are available 7 days a week. Visits are secure, discreet and confidential, and you have ongoing support with the same provider.

As an insured with Student Resources, there is no consultation fee for this service. Every communication with a provider is covered 100% during your policy period.
